
DID YOU KNOW? OVERCOMING COGNITIVE DISSONANCE

#1: VACCINE MAKERS ARE IMMUNE FROM LIABILITY

- Manufacturers cannot be sued, even if they are shown to be negligent
 - From 1986 National Childhood Vaccine Injury Act.
 - If you sue you sue the USA government, not the vaccine makers.
 - If you win, the vaccine makers don't pay the fines, the USA government does, aka USA tax payers.
 - & more recent PREP Act.
 - If you sue for covid vaccine injury you ... wait you can't sue for <u>covid vaccine</u> <u>injuries</u> under the PREP Act and EUA.



- Did you know COVID vax was rushed to market.
- It usually takes <u>5-20 years to bring a vaccine to market</u> yet the covid vax was done in 6 months, with very limited trial participants (no pregnant/lactating women, no elderly over 55, etc.) and skipped animal trials.
- Moderna had the first batch of vaccines ready 42 days after the viral sequence was identified.
- This of course is no problem for the vaccine makers since they have no liability if it goes bad.



#2 Did you know the vaccine companies are inexperienced and known FELONS?

- Of The four major companies:
- Moderna & Johnson & Johnson: Covid is their 1st vax to market.
- Pfizer & AstraZeneca: Serial felons
- Johnson & Johnson: 1st time and serial felon.
- 3 of them (not Moderna) have paid out tens of billions in damages when guilty for other drugs known to cause injuries and death (ex: Vioxx, Bextra, Celebrex, Thalidomide, and opioids).


If they willfully put harmful products out when they can be sued for billions, why would we EVER trust their product when there's NO liability?

#3: We've been working on a CORONAVIRUS VACCINE since the 1960's and have NO HISTORY OF SUCCESS.

- 1960's, when tried with RSV (Respiratory Syncytial Virus) vaccine for infants Result = babies got sick and some died.
- Past 20 years tried more with animal trials. Result = animals got sick and many died.
- The experimental Vax produced antibodies, but when children and animals exposed to the virus in the wild if created Antibody Dependent Enhancement (ADE) / aka Vaccine Enhanced Disease (VED) = the immune system produced a "cytokine storm" = immune system overwhelmingly attacked its own body. The result of this "success" of creating a lot of antibodies was that the children/animals got sick and/or died.

There's NO data to suggest their rushed vaccines have overcome <u>Antibody Dependent</u> <u>Enhancement</u> (ADE) / aka <u>Vaccine Enhanced Disease</u> (VED) and the ensuing cytokine storm.

#4: THERE'S HUGE "DATA GAPS" SUBMITTED TO THE FDA BY THE VACCINE MAKERS

- There's nothing about overcoming Vaccine Enhanced Disease = cytokine storm (and deaths).
- Did you know, to get the Emergency Use Auth (EUA) they used NO data on:
 - Anyone younger than age 18 or older than age 55
 - Pregnant or lactating mothers
 - Auto-immune conditions
 - Immunocompromised individuals
 - No data on transmission of covid
 - No data on preventing mortality from covid
 - No data on duration of protection from covid
- To see EUA docs showing the gaps look at this, or this at about page 46 and 48.

The CDC willfully hyperinflated the covid numbers, since the real numbers don't support blind and continual vaccine boosting.



#5: THERE'S NO ACCESS TO THE RAW DATA FROM THE TRIALS

- Why no data from Pfizer nor Moderna on the "90% and 95% effective" claims they touted?
- But they did use Lots of deceptive language
- Did you know the efficiency claims from Pfizer and Moderna came from "3,410 total cases of suspected, but unconfirmed covid-19 in the overall study population, 1,594 occurred in the vaccine group vs. 1,816 in the placebo group."? This tricky language made the vaccine group more effective, but BASED ON WHAT DATA? It was A Guess that people had covid?!? Why didn't they test to see? Why did the FDA allow that? Why are mandates being rolled out based on guesses (or worse, deception)?

#6: NO long term testing.

Usually takes 5-10 (to 20!) years to approve a new vax, yet this covid vax was pushed out in 6 months, with a super limited group (See data gaps in #4).

#7: NO INFORMED CONSENT.

- No agreement to being a part of an experimental trial on a new drug, just an "emergency" use push for our "safety" that skips all the real safety rules.
- Get the jab = experiment group. Don't get jab = control group.



#8: UNDER-REPORTING OF ADVERSE REACTIONS AND DEATH.

- Harvard study says less than 1% of AR's are reported!
- VAERS is reporting over 18,409 COVID vaccine deaths (and counting) and nearly 1.7 MILLION ARs as of 11.6.21. If that's just 1% of what's really happening, you begin to see the severity of this problem/biological warfare.

#11: THE OVERALL COVID DEATH RATE. .26 to .002%.

Did you know the common cold is a type of coronavirus?

Death rate for the cold/flu is about .1%.

CDC's own numbers says covid has a 99.74% survival rate.

#12: THE FALSE COVID DEATH NUMBERS.

- How did we get that 753k covid death number?
- New guidelines pushed Covid disease to be listed as the cause of death, EVEN if died of cancer or a heart attack.
- To falsify the number even more, both the W.H.O. and the C.D.C. said it just needed to suspected or be probable (never confirmed) of having died of covid!

Even criminal!




#14: FAUCI ILLEGAL BEHAVIOR




#16: CENSORSHIP...AND THE COMPLETE ABSENCE OF SCIENTIFIC DEBATE.

- Not allowed to ask any question on
 - Lockdowns
 - Mask wearing
 - Social-distancing
 - Vaccine efficacy and safety trials
 - How to screen for susceptibility to vaccine injury
 - Therapeutics, (i.e. non-vaccine treatment options)
- Instead public health officials (who never treated covid) dictate their "science". no panel publicly giving vaccine makers tough questions about products of which they have no liability.
- First Amendment: Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

#17: VACCINOLOGIST SOUNDS ALARM.

- Geert Vanden Bossche explains:
- Vaccines put pressure on the virus that accelerates its ability to mutate and become more deadly, creating vaccine-resistant viruses. Here's another talk on this.
- Since Antibody Dependent Enhancement never solved, may have mass casualty event in the next months/years.
- Did you know <u>masks don't work to fight Covid</u> pandemic?



#18: We can't vaccinate out of this pandemic.

- Getting COVID and <u>natural</u> <u>antibodies</u> are how to recover from this "plandemic". Those antibodies will protect and not have harmful side effects.
- Did you know if you got covid and recovered, there is evidence the covid vaccine might actually be more dangerous for you?





Reason #1: THE "VACCINES" ARE A MASSIVE FAILURE

- <u>Dr. Peter Doshi</u> (editor of the *British Medical Journal*—BMJ) says In early July 2021 Israel reports the vaccine was 64% effective. By late July 2021, Israel reported the vaccine was 39% effective.
- We aren't told efficacy rate after that because Pfizer supposedly doesn't have any data past six months into their trial. Mmm hmm.
- In the un-injected, human immune system remains 99.9% effective at beating covid.
- The Lancet article that says the absolute-risk reduction a jab confers is a whopping 1.3% decreased risk at best.
- Did you know many FDA "fully approved" drugs (that were studied for years) frequently got pulled from the market for being found out to be deadly? Ex: Vioxx, Celebrex, opioids, etc.?
- Does this data support a no-exceptions, twice-annual (or multi-annual) "immunity membership," passport, to live our lives?

#2: THE PANDEMIC OF THE VACCINATED

- Could it be that it's actually the <u>vaccinated</u> who are keeping covid going?
- Did you know Nobel Prize Winner Luc Montagnier says that "it is the vaccination that is creating the variants" of Covid?
- The more vaccinated a country (or state) becomes, the more there is a corresponding surge in covid deaths, and the surge is typically higher than the natural, pre-jab peak

Daily new confirmed COVID-19 deaths per million people



Shown is the rolling 7-day average. Limited testing and challenges in the attribution of the cause of death means that the number of confirmed deaths may not be an accurate count of the true number of deaths from COVID-19.



#2: THE PANDEMIC OF THE VACCINATED

- The jabs are completely failing to make a quantifiable difference in covid when compared to countries with low uptake rates.
- Did you know, those who take the shot are <u>becoming super spreaders</u>, says Dr Robert Malone.
- Did you know the CDC revised the definition of a vaccine? It was defined as "a product that stimulates a person's immune system to produce immunity to a specific disease, protecting the person from that disease". The new definition for the vaccine now reads, "A preparation that is used to stimulate the body's immune response against diseases." cutting out "producing Immunity".
- Did you know other nations are <u>barring Israelis from entering their country</u> from fear of them spreading COVID?

#3: VACCINES PRESSURE THE VIRUS TO MUTATE AND SKIRT OUR IMMUNE SYSTEMS

- Dr. Geert Vanden Bossche, respected vaccine scientist, put his entire (impressive) reputation on the line when he called for an immediate pause to the covid vaccine program, and asked for public debates among his peers.... But he was vilified and debates never happened.
- Dr Bossche told us that vaccinating people in the middle of an outbreak would:
 - Accelerate the virus' ability to mutate: Hello Alpha, Beta, Gamma, Delta, etc.
 - Inevitably produce vaccine-resistant strains: Hello new surge in infections.
 - Train the immune system to fixate on ONE specific piece of the original SARS CoV-2 virus (the spike protein) and thus be non-responsive to future variants.

#3: VACCINES PRESSURE THE VIRUS TO MUTATE AND SKIRT OUR IMMUNE SYSTEMS

- An immune system that is non-responsive to future variants = can make the common cold deadly = producing mass-casualty event.
- Did you know it is <u>mathematically impossible to inject our way out of covid?</u>
- Did you know that <u>Robert Malone</u>, the inventor of the mRNA vaccine say it is not safe for the general population to take, potentially deadly? The same with vaccine expert Dr Bossche. Both men risk their careers to speak out, at the top of their field. Why?

#4: CLEARLY-ESTABLISHED, HIGHLY-CONCERNING RISKS OF THE "VACCINES"

- FIRST, these shots, turn off your immune system's ability to recognize friend from foe.
- Part of the mechanism of action (<u>for which a Nobel Prize was awarded</u>) is that these injections cause the "toll-like receptors" of our immune system to not attack foreign mRNA. Toll-like receptors are the gatekeepers that empower the immune system to do things like:
 - Recognize native vs. foreign mRNA
 - Distinguish healthy cells from cancer cells
 - Put viruses in check so they remain dormant
- Leads to the return of <u>aggressive cancer</u> and the opportunity for <u>dormant viruses to remerge</u>.

#4: CLEARLY-ESTABLISHED, HIGHLY-CONCERNING RISKS OF THE "VACCINES"


- SECOND, we were told the injected spike proteins would stay hyper-local in the shoulder and thus the immune system would surround the enemy, learn its ways, clean up the injection site, and humoral (memory) immunity would confer protection.
- As it turns out, the logic of that first assumption makes as much sense as having a peeing section in a pool.
- In what's called a "biodistribution study" Japanese researchers found the spike protein (which is toxic) was able to travel through the entire body—including across the highly-sensitive, blood-brain barrier.
- Did you know The highest concentration of these spike proteins was actually found in the ovaries?
- Perhaps this explains why in <u>Pfizer's own study</u> (see page 67) they acknowledged there is a risk for pregnant women (via "inhalation and skin contact") if exposed to someone who has had the vaccine.
- Might that explain the reports of <u>menstrual</u>, <u>fertility</u> and <u>miscarriage</u> issues in women?
- Did you know scientists have been working on <u>vaccines that spread like a disease</u>?

#4: CLEARLY-ESTABLISHED, HIGHLY-CONCERNING RISKS OF THE "VACCINES"

- THIRD, these jabs also contain the instructions to turn your cells into spike-protein factories.
- Not only is the spike-protein what opens the cell wall to allow the virus inside, these spiky bits (whether from covid or from the jab) cause your cells to begin manufacturing a protein that can cause blood platelets to stick together, creating blood clots.
- With the right trigger, cells all over an injected person's body might not only simultaneously become a spike-protein factory that thickens the blood, but can also cause the immune system to start attacking any cells that make the spike protein.
- Makes potential micro clots (found on a D-Dimer test) as well as potential auto-immunity.
- Dangers already known from coronavirus animal testing 20 years ago (See #3 in 18 Reasons).
- Did you know the first autopsy (of a human who died after receiving the jab) showed every organ of the body infested with spike proteins.
- Why are seasoned Dr's and scientists signing <u>petitions to stop the jab program</u>? 12k Drs on one, 59k signed another.

Did you know that all vaccines injuries in the last 30 years combined don't equal the death and ARs we've seen in 2021 alone.






Are those last numbers skewed because no other vaccine has been used this widely?



Deaths Reported to VAERS per Million Vaccine Doses Since 2010




- Did you see this vid of Navy Surgeon saying the covid jab has killed more active-duty military than covid has?

- Did you know kids given these jabs, especially boys (age 12-17) are four to six times more likely to be hospitalized for myocarditis than covid. Myocarditis: swelling of the heart that produces permanent heart damage and sometimes death. That's not a normal 12 year old problem!

#7: THE SHAM "FULL FDA-APPROVAL" OF PFIZER'S JAB

- Did you know there is NO fully-approved covid jab available anywhere in the world? This is because the approved "Comirnaty" shot won't be available until 2023 or even 2024.
- Did you know even though the "approved jab" isn't available, the agenda is still pushing the Emergency Use Authorization (EUA) jab as interchangeable with the approved jab, but it's not!? Pfizer says "they're the same...but different" (see footnote 8 on page 2). It has come out that Pfizer will be held liable for injuries from the Comirnaty Vaccine, until it is officially put on the children's vaccine schedule... so it seems like they are pushing out the availability of it until then to avoid the possible (and probable) millions of people with severe reactions suing them out of business. Until then the EUA vax leaves the injured unable to sue or pursue damages no matter how bad the injury.

- Did you know The FDA is currently being taken to court because they broke the law and won't show the data they relied upon to approve the Comirnaty shot? Why won't they show the data?
- Did you know Pfizer redacted 22% of the ingredients (see pages 6 and following) in their new "approved" vaccine and the FDA had to be FOIA-ed (freedom of info act) to make some ingredients public.
- Did you know Pfizer hid from the public that they used aborted fetal cells in the production of their vaccines and we only found that out because of a Pfizer whistleblower?

#8: THE BOOSTER DEBACLE

- After a study of just 329 healthy people (12 people were over 65), with no control group, with just a time of "over two months", Pfizer boldly asked for a full approval to give a third shot of the same formulation...to ALL adults. Instead of skipping another advisory-council meeting to review the risk/benefit of approving another shot of the same dud, the VRBPAC committee DID meet this time.
- After a full-day, open-for-public-comment period, and after hearing doctor after doctor say things like this and this, they overwhelmingly (16-2) voted to **NOT** approve the booster shot. Yet, leave it to absent-minded Joe Biden to say afterward that the booster program is going forward "as planned" (foreshadowing the sham of having an advisory Council there to actually protect the people from danger).
- Shortly after the 16-2 vote, Biden's CDC director overruled the FDA advisory committee (ACIP) and approved the booster shot for those with "risky underlying health problems" (a pathologically-vague category).

- Why are we ignoring that the boosters are failing in Israel, and that the <u>European Union</u> and the <u>W.H.O.</u> are both recommended **against** boosters?
- Did you know two top FDA officials responsible for vaccine research resigned after strongly being asked to approve boosters and then signed a letter in *The Lancet* that strongly warns against vaccine boosters?

You are not a horse. You are not a cow. Seriously, y'all. Stop it.





#10: NATURAL IMMUNITY TO COVID IS FAR SUPERIOR TO VACCINE-INDUCED IMMUNITY

- Did you know Fauci and CDC says vax immunity is better but these 81 studies say Natural immunity is better?
- Did you know the Pfizer jab has been shown to diminish in efficacy (not work) within 2 months?
- <u>Dr. Hooman Noorchasm</u> says we have to acknowledge natural immunity is not only superior to vaccine-induced immunity, but is clear justification to avoid the jab altogether.
- Scott Gottlieb, former head of the FDA (who is currently on the board of advisors at Pfizer), says we have to bring natural immunity into the equation of who needs these shots. As opposed to saying pharma's chemical cocktail is better than nature (god). so, why can't the naturally infected opt out?

#11: THESE "VACCINES" REGRESS THE IMMUNE SYSTEM

- Did you know the virologist <u>Geert Vanden Bossche</u> says the jab causes the immune system of previously naturally-infected people (have natural immunity) to become blind to any version of covid that doesn't have the original, un-mutated, spike protein. Meaning once covid mutates (he says it does every 10 minutes!) the vax no longer works.
- An Israeli study confirmed that you're 13 times more likely to get a breakthrough infection if you GET the jab.
- Another Israeli study (may of 2021) With a total of 835,792 Israelis known to have recovered naturally from the virus without the vax, had 72 instances of reinfection = amount to 0.0086% of people who had been naturally infected with COVID. By contrast, Israelis who were vaccinated were 6.72 times more likely to get infected after the shot than after natural infection, with over 3,000 infected of the 5,193,499 vaccinated, or 0.0578% That got infected again anyway.
- BUT WORSE! According to <u>this study</u>, the vaccinated appear to have a "total immune system degradation" of 40% of their immune-system capability. The danger of "boosting" the immune system is this potential for a phenomenon called "<u>immune exhaustion</u>." Where you can't fight ANYTHING, any sickness off! The common cold can kill you!



#13: THE PATENT RECORD

- Did you know it's illegal to patent a living organism? Yet Since 1999, over 4,000 patents have been filed on coronaviruses. How they get around patenting an organism? They didn't. They could because its laboratory altered, or engineered, not natural.
- 123 of those patents cover every aspect of what is supposedly "novel" about SARS-CoV-2. The entire virus (as well as the antidotes and means of detecting the virus), received patents long before covid-19.




